A BILL FOR AN ACT

To appropriate the sum of \$2,000 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding Kosrae's participation to the Councils of the Pacific Islands Traditional Leadership (CPITL) Conference; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$2,000 is hereby appropriated from the Local
2 Revenue Fund of the Kosrae State Treasury for the purpose of funding the Kosrae's participation
3 to the Councils of the Pacific Islands Traditional Leadership (CPITL) Conference which will be
4 held in Pohnpei State.

5 Section 2. Allotment. All funds appropriated by this act shall be allotted, managed,
6 administered and accounted for in accordance with applicable laws. The allottee of the funds
7 appropriated shall be the Governor of the State of Kosrae. The allottee shall be responsible for
8 ensuring that these funds, or so much thereof as may be necessary, are used solely for the
9 purpose specified in this act and that no obligations are incurred in excess of the sum
10 appropriated.

11 Section 3. Effective Date. This act takes effect upon the approval of the Governor or
12 upon its becoming law without such approval.
