

A BILL FOR AN ACT

To appropriate the sum of \$25,000 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the additional capital contributions to the Pacific Islands Development Bank (PIDB); and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriate. The sum of \$25,000 is hereby appropriated from the Foreign  
2 Assistance of the Kosrae State Treasury for the purpose of funding the additional capital  
3 contributions to the Pacific Islands Development Bank (PIDB) in the State of Kosrae.

4           Section 2. Allotment. All funds appropriated by this act shall be allotted, managed,  
5 administered and accounted for in accordance with applicable laws. The allottee of the funds  
6 appropriated shall be the Governor of the State of Kosrae. The allottee shall be responsible for  
7 ensuring that these funds, or so much thereof as may be necessary, are used solely for the  
8 purpose specified in this act and that no obligations are incurred in excess of the sum  
9 appropriated.

10           Section 3. Effective Date. This act takes effect upon the approval of the Governor or  
11 upon it becoming law without such approval.
