A BILL FOR AN ACT

To amend State Law No. 10-46, at Section 2(1)(c) to supplement the operation of the Office of the Governor for the fiscal year ending September 30, 2013; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to supplement the operation of the Office
2 of the Governor by providing \$2,000 from the Revenue Fund for the representation fund for the
3 Governor and the Lieutenant Governor for the fiscal year ending September 30, 2013.

4 Section 2. Amendment. State Law 10-46, at Section 2(1)(c), is hereby amended to read
5 as follows:
