A BILL FOR AN ACT

To appropriate the sum of \$159,311 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding certain projects in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$159,311 is hereby appropriated from the Foreign
2 Assistance Fund of the Kosrae State Treasury for the purpose of funding certain projects in the
3 State of Kosrae.

4 Section 2. Apportionment. The sum appropriated by Section 1 of this act is apportioned
5 as follows:

6 (1) DTI Project for Provision of Equipment for garbage disposal.....\$95,000

7 (2) DREA Project for Development of Small-scale Fisheries.....\$64,311

8 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
9 administered and accounted for in accordance with applicable laws. The allottee of the fund
10 appropriated by this act shall be the Governor of the State of Kosrae, who shall be responsible
11 for ensuring that these funds, or so much thereof as may be necessary, are used for the purpose
12 for which are appropriated and that no obligations are incurred in excess of the sum
13 appropriated.

14 Section 4. Effective Date. This act takes effect upon the approval of the Governor or
15 upon its becoming law without such approval.
