

A BILL FOR AN ACT

To appropriate the sum of \$1,000.00 from the Revenue Fund of the Kosrae State Treasury for the purpose of funding June 2011 Celebration for Malem Municipal Government; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to appropriate the sum of \$1,000.00 (“One  
2   Thousand dollars”) from the Revenue Fund of the Kosrae State Treasury to fund the June 2011  
3   Celebration for Malem Municipal Government.

4           Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,  
5   administered and accounted for in accordance with applicable laws. The allottee of funds  
6   appropriated by this act shall be the Governor of the State of Kosrae who shall be responsible for  
7   ensuring that these funds, or so much thereof as may be necessary, are used solely for the  
8   purpose specified in this act, and that no obligations are incurred in excess of the sum are  
9   appropriated. The lapse date for the said fund shall be no later than September 30, 2011.

10          Section 3. Effective Date. This act takes effect upon the approval of the Governor or  
11   upon its becoming law without such approval.
