



A BILL FOR AN ACT

To appropriate the sum of \$7,800 from the Revenue Fund of the Kosrae State Treasury to provide funding for the maintenance of Road Sections-1, 2, 2(a), 2(b) and 5 in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$7,800 is hereby appropriated from the Revenue
2 Fund of the Kosrae State Treasury for the purpose of providing funding for the maintenance of
3 Road Sections-1, 2, 2(a), 2(b) and 5 in the State of Kosrae.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered and accounted for in accordance with applicable laws. The allottee of the fund
6 appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be
7 responsible for ensuring that these funds, or so much thereof as may be necessary, are used for
8 the purpose specified in this act and that no obligations are incurred in excess of the sum
9 appropriated.

10 Section 3. Effective Date. This act shall become law upon approval by Governor or
11 upon its becoming law without such approval.
