A BILL FOR AN ACT

To appropriate the sum of \$7,860 from the Revenue Fund of the Kosrae State Treasury to provide funding for the development projects in Lelu Municipality; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$7,860 is hereby appropriated from the Revenue
2 Fund of the Kosrae State Treasury for the purpose of providing funding for fuel for development
3 projects in the Lelu Municipality as addressed to the Legislature in Lelu CR No. 09-01, CR No.
4 09-02 and Municipal Government Message No. 10-35.

5 Section 2. Apportionment. The appropriated sum of \$7,860 in Section 1 of this Act is
6 apportioned as follows:

7	(1) Coastal Erosion	7 Drums (371 gal. diesel)	\$260.00 ea.	\$1,620.00
8	(2) Access Roads	9 Drums (477 gal. diesel)	\$260.00 ea.	\$2,340.00
9	(3) Farm Roads	9 Drums (477 gal. diesel)	\$260.00 ea.	\$2,340.00
10	(4) Cross Island Rd	6 Drums (318 gal. diesel)	\$260.00 ea.	\$1,500.00

11 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
12 administered and accounted for in accordance with applicable laws. The allottee of the fund
13 appropriated by this act shall be the Governor of the State of Kosrae. The allottee shall be
14 responsible for ensuring that these funds, or so much thereof as may be necessary, are used for
15 the purpose specified in this act and that no obligations are incurred in excess of the sum
16 appropriated.

1 Section 4. Reporting Requirement. Lelu Municipal Government shall provide a
2 quarterly progress report, additional expense report to the Governor of the State of Kosrae.

3 Section 5. Effective Date. This act shall become law upon approval by Governor or
4 upon its becoming law without such approval.
