

A BILL FOR AN ACT

To appropriate the sum of \$7,000.00 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing funding for Liberation Day celebration of the four municipalities; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$7,000.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury for the purpose of providing funding for the
3 Liberation Day celebration of the four municipalities.

4 Section 2. Apportionment. The amount appropriated under Section 1 of this act is
5 hereby apportioned as follow:

6	1) Lelu	\$2,000.00
7	2) Tafunsak	\$2,000.00
8	3) Malem	\$1,500.00
9	4) Utwe	\$1,500.00

10 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
11 administered and accounted for in accordance with applicable laws. The allottee of the funds
12 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
13 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
14 appropriated and that no obligations are incurred in excess of the sum appropriated.

15 Section 4. Effective Date. This act shall become law upon approval by the Governor or
16 upon its becoming law without such approval.


