





A BILL FOR AN ACT

To appropriate the sum of \$245,925 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding certain public projects and social programs in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$245,925 is hereby appropriated from the Foreign
2 Assistance Fund of the Kosrae State Treasury for the purpose of funding certain public projects
3 and social programs in the State of Kosrae.

4 Section 2. Apportionment. The sum appropriated by Section 1 of this is hereby
5 apportioned as follows:



7 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
8 administered and accounted for in accordance with applicable laws. The allottee of the funds
9 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
10 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
11 appropriated and that no obligations are incurred in excess of the sum appropriated.

12 Section 3. Effective Date. This act shall become law upon approval by the Governor or
13 upon its becoming law without such approval.
