

A BILL FOR AN ACT

To appropriate the sum of \$388,635 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the Road Upgrading Project from Utwe to Walung in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$388,635 is hereby appropriated from the Foreign
2 Assistance Fund of the Kosrae State Treasury for the purpose of funding the Road Upgrading
3 Project from Utwe to Walung in the State of Kosrae.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered and accounted for in accordance with applicable laws. The allottee of the funds
6 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
7 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
8 appropriated and that no obligations are incurred in excess of the sum appropriated.

9 Section 3. Effective Date. This act shall become law upon approval by the Governor or
10 upon its becoming law without such approval.
