



A BILL FOR AN ACT

To amend the Kosrae State Code at Title 7, Section 7.804 (1)(g) to require the Health Advisory Board to appear, in person, before the Legislature to present the quarterly progress report as mandated in this section; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. To amend the Kosrae State Code at Title 7, Section 7.804 (1)(g) to
2 require the Health Advisory Board to appear, in person, before the Legislature to present the
3 quarterly progress report as mandated in this section in order to enhance the current reporting
4 procedures of the Board and to provide the Legislature with efficient reporting.

5 Section 2. Amendment. Title 7, Section 7.804(1)(g) of the Kosrae State Code is hereby
6 amended to as follows:

7 “(g) Provide a quaterly report to the Governor and the Speaker within ten (10)
8 business days after the months of March, June, September and December on the progress made
9 by the Department of Health Services in meeting the goals enumerated in this section and to
10 appear, in person, before the Legislature when necesssary.”

11 Section 3. Effective Date. This act takes effect upon the approval of the Governor or
12 upon its becoming law without such approval.


