





A BILL FOR AN ACT

To amend the Kosrae State Code at Title 7, Section 7.704 (2)(h) to amend the requirement for a report to the Governor and Legislature from an annual to a quarterly basis and to require the Education Advisory Board to appear, in person, before the Legislature to present that report; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. To enhance the current reporting process and provide the
2 Legislature with current relevant issues of the Department by amending the Kosrae State Code at
3 Title 7, Section 7.704 (2)(h) to amend the reporting requirement as mandated upon the Education
4 Advisory Board to report to the Governor and Legislature from an annual basis to a quarterly
5 basis and to require the Board to appear, in person, before the Legislature to present that report.

6 Section 2. Amendment. Title 7, Section 7.704(2)(h) of the Kosrae State Code is hereby
7 amended to as follows:

8 “(h) Provide a quarterly report to the Governor and the Legislature on the
9 progress made by the Department of Education in meeting the goals enumerated in this
10 subsection and to appear, in person, before the Legislature when necessary.”

11 Section 3. Effective Date. This act takes effect upon the approval of the Governor or
12 upon its becoming law without such approval.




