
BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE


1 Section 1. Authorization. The sum of \$172,629 from the old Compact of Free
2 Association or Compact I fund is hereby authorized be used for indentified and allowable prior
3 year expenditures incurred under the General Fund of the Kosrae State.

4 Section 2. Effective Date. This act shall become law upon approval by the Governor or
5 upon its becoming law without such approval.
