

A BILL FOR AN ACT

To appropriate the amount of \$3,500.00 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the annual Local Close-Up Program to be held in Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE:

1 Section 1. Appropriation. To appropriate the sum of \$3,500.00 is hereby appropriated
2 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the
3 24th Local Close-Up Program to be held in Kosrae.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered and accounted for in accordance with applicable laws. The allottee of the funds
6 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
7 that these funds, or so much thereof as may be necessary, are used for the purpose for which are
8 appropriated and that no obligations are incurred in excess of the sum appropriated. The
9 authority of the allottee to obligate funds are incurred by this act shall lapse on September this
10 act shall lapse on September 30, 2015.


11 Section 3. Effective Date. This act shall become law upon approval by the Governor or
12 upon its becoming law without such approval.
