**A BILL FOR AN ACT**

To appropriate the sum of \$11,500 from the Revenue Fund of the Kosrae State Treasury to provide financial assistance to the Raimond Taro Flour Company and Wa Wa Chips Company; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$11,500 is hereby appropriated from the  
2 Revenue Fund of the Kosrae State Treasury to provide financial assistance to the  
3 Raimond Taro Flour Company and Wa Wa Chips Company.

4           Section 2. Apportionment. The amount appropriated in Section 1 of this act  
5 is apportioned as follows:

10          Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
11 administered and accounted for in accordance with applicable laws. The allottee of the  
12 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible  
13 for ensuring that these funds, or so much thereof as may be necessary, are used for the  
14 purpose for which are appropriated and that no obligations are incurred in excess of the  
15 sum appropriated.

16          Section 4. Effective Date. This act takes effect upon the approval of the  
17 Governor or upon its becoming law without such approval.


