



**A BILL FOR AN ACT**

To amend S.L. No. 11-93 and insert certain projects apportioning unallocated amounts titled “TBD”; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. To amend Section 2 of the Kosrae State Law No. 11-93,  
2           to insert certain projects and apportion the amount titled “TBD”; and for other  
3           purposes. The sum of \$900,000 is hereby appropriated from the Foreign Assistance  
4           Fund of the Kosrae State Treasury for the purpose of funding priority infrastructure  
5           projects in the State of Kosrae, and for other purposes.

6           Section 2. Amendments. The sum appropriated herein shall be apportioned as  
7           follows:

8	1.	Pual Shoreline Protection Project	\$94,999
9	2.	Inkewosr Seawall	\$5,496
10	3.	Mosral Shoreline Protection Project	\$180,000
11	4.	Road Resealing	\$619,505

12           Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be  
13           allotted, managed, administered and accounted for in accordance with applicable laws.  
14           The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who  
15           shall be responsible for ensuring that these funds, or so much thereof as may be  
16           necessary, are used for the purpose for which are appropriated and that no obligations  
17           are incurred in excess of the sum appropriated. The authority of the allottee to obligate  
18           funds appropriated by this act shall lapse on September 30, 2018.

1 Section 4. Effective Date. This act shall become law upon approval by the  
2 Governor or upon its becoming law without such approval.
