A BILL FOR AN ACT

To appropriate the sum of \$2,000 from the Local Revenue Fund of the Kosrae State Treasury to contribute funding for awards of goods to the 2017 June 6th Memorial Holiday and related celebrations and festivities of the Malem community; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. Appropriation. The sum of \$2,000 is hereby appropriated from the 1 Revenue Fund of the Kosrae State Treasury for the purpose of contributing funding 2 for awards of goods to the 2017 June 6th Memorial Holiday and related celebrations 3 4 and festivities of the Malem community. Section 2. All funds appropriated by this act shall be allotted, 5 managed, administered, and accounted for in accordance with applicable laws. The 6 7 allottee of the funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that these funds, or so much thereof as may be 8 necessary, are used for the purpose for which are appropriated and that no obligations 9 10 are incurred in excess of the sum appropriated. Section 3. Effective Date. This act shall takes effect upon the approval of the 11 Governor or upon its becoming law without such approval. 12 13 PASSED BY THE ELEVENTH KOSRAE STATE LEGISLATURE ON THE 24th DAY 14 15 OF MAY, 2017. 16
