

A BILL FOR AN ACT

To appropriate the sum of \$650,000 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the operation and activities of the Community Health Center (CHC) in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$650,000 is hereby appropriated
2 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of
3 funding the operations and activities of the Community Health Center in the State of
4 Kosrae.

5 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in accordance with applicable laws.
7 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
8 shall be responsible for ensuring that these funds, or so much thereof as may be
9 necessary, are used for the purpose for which are appropriated and that no obligations
10 are incurred in excess of the sum appropriated. The authority of the allottee to obligate
11 funds appropriated by this act shall lapse on May 31, 2018.

12 Section 3. Effective Date. This act shall become law upon approval by the
13 Governor or upon its become law without such approval.




