## A BILL FOR AN ACT

To appropriate the sum of \$450,000 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of purchasing the outstanding shares and all assets of the Kosrae Industrial Development Co (KIDCO); and for other purposes.

## BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. Appropriation. The sum of \$450,000 is hereby appropriated from the
2	Foreign Assistance Fund of the Kosrae State Treasury for the purpose of purchasing the
3	outstanding shares and all assets of the Kosrae Industrial Development Co (KIDCO) in
4	the State of Kosrae and for other purposes.
5	Section 2. All funds appropriated by this act shall be allotted, managed
6	administered and accounted for in accordance with applicable laws. The allottee of the
7	funds appropriated shall be the Governor of the State, who shall be responsible for
8	ensuring that these funds, or so much thereof as may be necessary, are used for the
9	purpose for which are appropriated and that no obligations are incurred in excess of the
10	sum appropriated.
11	Section 3. Effective Date. This act shall become law upon approval by the
12	Governor or upon it's become law without such approval.
