A BILL FOR AN ACT

To further amend S.L. No. 11-93, as amended by S.L. No. 11-106, to be consistent with amendment reflected in P.L. No. 11-20-05; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this amendment is to further amend Section 2  
2 of S.L. No. 11-106, to be consistent with P.L. No. 20-05.

3           Section 2. Amendment. Section 2 of S.L. No. 11-93, as amended by S.L. No. 11-  
4 106 is hereby further amended to read as follows:

5                     Section 2. Amendments. The sum appropriated herein shall be  
6 apportioned as follows:

- 7                     1.     Utwe Water System (purchase of equipment, material parts and  
8                                 repair works to maintain distribution line.....     \$300,000  
9                     2.     Primary Road Improvement Projects.....     \$600,000

10           Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
11 administered and accounted for in accordance with applicable laws. The allottee of the  
12 fund appropriated by this act shall be the Governor of the State of Kosrae. The allottee  
13 shall be responsible for ensuring that these funds, or so much thereof as may be  
14 necessary, are used solely for the purpose specified in this act and that no obligations are  
15 incurred in excess for the sum appropriated. The authority of the allottee to obligate funds  
16 appropriated by this act lapse on September 30, 2018.

17           Section 4. Effective Date. This act shall become law upon approval by the  
18 Governor or upon it's becoming law without such approval.
