A BILL FOR AN ACT

To further amend S.L. No. 11-75, as amended by S.L. Nos. 11-85 and 11-96, to eliminate certain projects, reduce amount appropriated for certain projects and redirect funding to other projects; apportion unallocated amounts titled "TBD"; and for other purposes.

BE IT ENACTAED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. To further amend S.L. No. 11-75, as amended by S.L. No.
2 11-85 and S.L. No. 11-96, to eliminate certain projects and redirect funding to other
3 projects; apportion unallocated amounts titled "TBD"; and for other purposes. The sum
4 of \$1,500,000 is hereby appropriated from the Foreign Assistance Fund of the Kosrae
5 State Treasury for the purpose of funding priority infrastructure projects in the
6 in the State of Kosrae, and for other purposes.

7 Section 2. Amendments. The sum appropriated herein shall be apportioned
8 as follows:

12 Section 3. Allottee. All funds appropriated by this act shall be allotted,
13 managed, administered and accounted for in accordance with applicable laws. The
14 allottee shall be responsible for ensuring that these funds, or so much thereof as may
15 be necessary, are used solely for the purpose specified in this act and that no
16 obligations are incurred in excess of the sum appropriated. The authority of the allottee
17 to obligate funds appropriated by this act shall lapse on September 30, 2018.

18 Section 4. Effective Date. This act shall become law upon approval by the
20 Governor or upon its becoming law without such approval.


