



A BILL FOR AN ACT

To further amend State Law No. 11-61, as amended by State Law No. 11-78, amending Section 11 thereof, to provide extension on the lapse date for the operation funding for the Project Management Office; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to extend the lapse date for the
2 operation of funding of the Project Management Office.

3 Section 2. Amendment. Section 11 of State Law No. 11-61 as amended in State
4 Law No. 11-78 is hereby further amended to read as follows:

5 Section 11. Appropriation. The sum of \$3,579,709, or so much thereof
6 as may be necessary, is appropriated from the Amended Compact Fund for the
7 purpose of funding certain Governmental programs, grants and contributions for
8 the fiscal year ending September 30, 2016. Funding for subsection (4) of this act
9 extended through March 31, 2018.

10 Section 12. Apportionment. The sum appropriated by Section 11 of this
11 act is apportioned as follows:

16 Section 3. Effective Date. This act shall become law upon approval by the
17 Governor or upon its becoming law without such approval.
