A BILL FOR AC ACT

To appropriate the sum of \$50,000.00 from the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding certain projects and programs in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. <u>Purpose</u> . The sum of \$50,000.00 from the Foreign Assistance Fund						
2	of the Kosrae State Treasury for the purpose of funding certain projects and programs in						
3	the State of Kosrae.						
4	Section 2. <u>Apportionment</u> . The sum appropriated by Section 1 of this act is						
5	hereby apportioned as follows:						
6	1. Local Economic Activity Stimulus\$28,000						
7	2. Export Support\$13,000						
8	3. Chamber Capacity Building\$5,000						
9	4. Communications/Public Awareness\$1,000						
10	5. Tourism Support\$3,000						
11	Section 3. <u>Allottee</u> . All funds appropriated by this act shall be allotted,						
12	managed, administered and accounted for in accordance with applicable laws. The						
13	allottee of the funds apportioned shall be the Governor of the State of Kosrae, who						
14	shall be responsible for ensuring that these funds, or so much thereof as may be						
15	necessary, are used for the purpose for which are appropriated and that no obligations						
16	are incurred in excess of the sum appropriated.						

1	Section 4. Effective Date. This act shall become law upon approval by the
2	Governor or upon its becoming law without such approval.
