

A BILL FOR AN ACT

To further amend Title 18, Section 18.503 at Chapter 5 of the Kosrae State Code by codifying compensation for panel members of ad hoc committee hearings for the State Government; and for other purposes.

BE IT ENACTED BY THE ELEVENTH KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to codify compensation for pane
2 members of ad hoc committee hearings. The ad hoc committee is not an agency
3 governing body by the members are state appointed, thus Section 7.113 may be
4 applicable.

5 Section 2. Amendment. Title 18, Section 18.503 at Chapter 5 of the Kosrae State
6 Code is hereby amended to read as follows:

7 Section 18.503. Appeal Panel. Each Branch Head shall appoint not fewer than
8 five person to constitute a panel from which ad hoc committees may be draw for the
9 purposes set forth in this Title. Each person shall be appointed for a two year term.
10 The Branch Head may remove any of his appointments for cause. Persons appointed
11 shall be non-exempt employees for the Kosrae State Government, of mature judgment
12 and experience. The panel should include at least one member from each of the three
13 branches of government. A panel member receives a compensation of \$20 when
14 physically attend an ad hoc committee hearing.

15 Section 3. Effective Date. This act takes effect upon the approval of the
16 Governor or upon its becoming law without such approval.
