

A BILL FOR AN ACT

To amend Section 7.606 of Title 7 of the Kosrae State Code, to require equal representation of the four (4) Municipalities in the composition of the Kosrae Port Authority Board; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to amend Section 7.606 of the
2 Kosrae State Code to require the Governor to appoint one representative for each of the
3 four (4) Municipalities of the Kosrae Port Authority Board.

4 Section 2. Amendments. Title 7, at Section 7.606 of the Kosrae State Code is
5 hereby amended as follows:

6 Section 7.606. Composition of the Board; term.

7 The Authority is governed by a Board of five Directors. The Board is
8 composed of four Directors, one from each of the Municipalities, appointed by
9 the Governor with the advice and consent of the Legislature, and, ex-officio, the
10 Director of the Department of Transportation and Infrastructure. An appointed
11 Director serves for a term of four years, subject to reappointment, and until his
12 successor has been appointed and qualifies. Initially, the Governor appoints two
13 Directors to two year terms and two Directors for four year terms. A vacancy is
14 filled for a remainder of the term for the vacated position.

15 Section 3. Effective Date. This act shall effect upon the approval of the
16 Governor or upon its becoming law without such approval.
