A BILL FOR AN ACT

To appropriate the sum of \$5,000 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding a follow-up trip to Pohnpei State.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to fund a follow-up trip to a
2 delegation of the Eleventh Kosrae State Legislature to make an assessment evaluation of
3 the former LNO Office situated in Pohnpei State. The premise is known to be a property
4 of Kosrae State Government.

5 Section 2. Appropriation. The amount of \$5,000 is hereby appropriated from the
6 Local Revenue Funds of the Kosrae State Treasury for the purpose of funding a
7 follow-up trip to Pohnpei State and return.

8 Section 3. Allottee. All funds appropriated by this act shall be allotted,
9 managed, administered and accounted for in accordance with applicable laws. The
10 allottee of the funds appropriated shall be the Governor of the State of Kosrae, who shall
11 be responsible for ensuring that these funds, or so much thereof as may be necessary, are
12 used for the purpose for which are appropriated and that no obligations are incurred in
13 excess of the sum approved.

14 Section 4. Effective Date. This act shall become law upon approval by the
15 Governor or upon its becoming law without such approval.
