

A BILL FOR AN ACT

To appropriate the sum of \$260,245 from the Amended Compact Fund of the Kosrae State Treasury to fund FY2018 Compact prior-year/unallocated-funded projects.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. Appropriation. The amount of \$260,245 is hereby appropriated from
2	the Amended Compact Fund of the Kosrae State Treasury for the purpose of funding the
3	FY2018 Compact prior-year/unallocated-funded projects.
4	Section 2. Apportionment. The sum appropriated herein above shall be
5	apportioned as follows:
6	a. Kosrae State HYBRID Survey \$105,745
7	b. SDP Review & Update \$154,500
8	Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be
9	allotted, managed, administered and accounted for in accordance with applicable laws.
10	The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
11	shall be responsible for ensuring that these funds, or so much thereof as may be
12	necessary, are used for the purpose for which are appropriated and that no obligations are
13	incurred in excess of the sum appropriated. The authority of the allottee to obligate funds
14	appropriated by this act shall lapse on September 30, 2018.
15	Section 4. Effective Date. This act shall become law upon approval by the
16	Governor or upon its becoming law without such approval.
