

A BILL FOR AN ACT

To appropriate the sum of \$5,000 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing financial assistance to the College of Micronesia – FSM, Kosrae Campus’s fundraising efforts for its Endowment Fund; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$5,000 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury to provide financial assistance to the
3 College of Micronesia – FSM, Kosrae Campus’s Endowment Fund.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered, and accounted for in accordance with applicable laws. The allottee of the
6 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
7 for ensuring that these funds, or so much thereof as may be necessary, are used for the
8 purpose of which are appropriated and that no obligations are incurred in excess of the
9 sum appropriated.

10 Section 3. Effective Date. This act takes effect upon the approval of the
11 Governor or upon its becoming law without such approval.
