

A BILL FOR AN ACT

To appropriate the sum of \$73,300 from the United States Grant Fund of the Kosrae State Treasury to fund the Office of the Public Auditor.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The amount of \$73,300 is hereby appropriated from the
2 United States Grand Fund of the Kosrae State Treasury for the purpose of funding the
3 Office of the Public Auditor – training and hiring of an Audit Investigation Advisor.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
5 allotted, managed, administered and accounted for in accordance with applicable laws.
6 The Allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
7 shall be responsible for ensuring that these funds, or so much thereof as may be
8 necessary, are used for the purpose for which are appropriated and that no obligations are
9 incurred in excess of the sum appropriated. The authority of the allottee to obligate funds
10 appropriated by this act shall lapse on September 30, 2019.

11 Section 3. Effective Date. This act shall become law upon approval by the
12 Governor or upon its becoming law without such approval.




