



A BILL FOR AN ACT

To amend Section 17.301 of Title 17 Chapter 3 of the Kosrae State Code thereof, to increase license fee from six dollars to twelve dollars; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Findings and Purpose. It was highly recommended during the most
2 recent State Leadership Conference that the State should find each and every possible
3 mechanisms in terms of revenue generating to assist the financial constraints of the
4 State. Amongst the several options identified as revenue mechanisms to increase the
5 license fee.

6 Section 2. Amendments. Section 17.301 of Title 17, Chapter 3 of the Kosrae
7 State Code is hereby amended to read as follows:

8 “Section 17.301. License. A person does not operate a motor vehicle unless
9 licensed as an operator pursuant to this chapter. The license fee is twelve dollars. A
10 license issued by another jurisdiction is valid within the State for thirty days following
11 the licensee’s entry into the State.”

12 Section 3. Effective Date. This act shall take effect upon its approval by the
13 Governor or upon its becoming law without such approval.




