A BILL FOR AN ACT

To further amend Title 14 of the Kosrae State Code, by amending Section 14.108 thereof, to provide that the State's share of the port and dock fees be deposited into the State's Revenue Fund; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to amend Section of Title 14, at
2 Section 14.108 of the Kosrae State Code require that State's share of the port and dock
3 fees be deposited into the State's Revenue Fund.

4 Section 2. Amendment. Title 14, Section 14.108 of the Kosrae State Code is
5 hereby amended to read as follows:

6 "Section 14.108. Deposit of the State's share of port and dock fees. The State's
7 share of the fees collected pursuant to Section 14.108(5) of this chapter shall be deposited
8 in the State's Revenue Fund."

9 Section 3. Effective Date. This act takes effect upon the approval of the
10 Governor or upon its becoming law without such approval.
