

A BILL FOR AN ACT

To further amend State Law No. 11-71 thereof, to revert and deposit any funds subjected for the Tobacco Coalition programs including any funds previously accounted for the program prior to the established account, into the Tobacco Coalition Revolving Fund account; and for other purposes.

BE IN ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to revert and deposit any funds
2 subjected for the Tobacco Coalition programs, including any accounts collected prior to
3 the establishment of the Tobacco Coalition Revolving Fund account.

4 Section 2. Amendments. Subsection 10.205(n) amended to read as follows:

5 Section 10.205. The Revolving Fund.

6 “(n) The Division of Finance and Budget retains in a Tobacco Coalition Fund all
7 monies collected from payments received for fees and fines from tobacco solely
8 for the purpose of funding operations of the Tobacco Coalition Taskforce,
9 including any funds collected prior to establishment of this fund.”

10 Section 3. Effective Date. This act takes effect upon the approval of the
11 Governor or upon its become law without such approval.
