

A BILL FOR AN ACT

To appropriate the sum of \$200.00 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the activities of the 2015 Kosrae Cultural Day; and for other purposes.

1 Section 1. Appropriation. The sum of \$200.00 is hereby appropriated from the
2 Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding
3 activities of the 2015 Kosrae Cultural Day.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered and accounted with applicable laws. The allottee of the funds appropriated
6 shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that
7 these funds, or so much thereof as may be necessary, are used for the purpose for which
8 are appropriated and that no obligations are incurred in excess of the sum appropriated.
9 The authority of the allottee to obligate funds appropriated by this act shall lapse on
10 September 30, 2015.

11 Section 3. Effective Date. This act shall become law upon approval by the
12 Governor or upon its become law without such approval.
