

A BILL FOR AN ACT

To appropriate the sum of \$100,000.00 from the Foreign Assistance Fund of the Kosrae State Treasury to support the participation of Kosrae State to the 9th Micro Games in the State of Yap; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$100,000.00 is hereby appropriated from
2 the Foreign Assistance Fund of the Kosrae State Treasury to provide support for the
3 Kosrae State's participation in the 9th Micro Games to be held in the State of Yap; and
4 for other purposes.

5 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in accordance with applicable laws.
7 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
8 shall be responsible for ensuring that these funds, or so much thereof as may be
9 necessary, are used for the purpose for which are appropriated and that no obligations are
10 incurred in excess of the sum appropriated. The authority of the allottee to obligate
11 funds appropriated by this act shall lapse on September 30, 218.

12 Section 3. Effective Date. This act takes effect upon the approval of the
13 Governor or upon its becoming law without such approval.
