A BILL FOR AN ACT

To appropriate the sum of \$1,000.00 from the Revenue Fund of the Kosrae State Treasury to subsidize the June 6, 2015 Commemoration in Malem Municipality; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$1,000.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury to subsidize the June 6, 2015
3 commemoration in Malem Municipality.

4 Section 1. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered and accounted for in accordance with applicable laws. The allottee of the
6 fund appropriated by this act shall be the Governor of the State of Kosrae. The allottee
7 shall be responsible for ensuring that these funds, or so much thereof as may be
8 necessary, are used solely for the purpose specified in this act and that no obligations
9 are incurred in excess of the sum appropriated.

10 Section 3. Effective Date. This act takes effect upon approval of the Governo.
11 or upon it becoming law without such approval.
