

A BILL FOR AN ACT

To amend S.L. No. 11-147, by eliminating certain projects and de-appropriation respective funding to be consistent with P.L. No. 20-79; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. To amend S.L. No. 11-147, by eliminating certain projects
2 and de-appropriating respective funding to be consistent with P.L. No. 20-79 and for
3 other purposes. P.L. No. 20-79 de-appropriate an amount of \$800,000 from the Capital
4 and Human Resources Development for the State of Kosrae; hence reducing the initial
5 appropriation of \$1.5 Million dollars under P.L. No. 19-32, that was further amended by
6 P.L. Nos. 1-45, 19-61, 19-83, 19-95, 19-122, and 20-79, to \$700,000.

7 Section 2. Amendments. The sum appropriated herein shall be apportioned as

9 Section 3. Allottee. All funds appropriated by this act shall be allotted,
10 managed, administered, and accounted for in accordance with applicable laws. The
11 allottee of the funds appropriated shall be the Governor of the State of Kosrae, who shall
12 be responsible for ensuring that these funds, or so much thereof as may be necessary, are
13 used for the purpose for which appropriated and that no obligations are incurred in excess
14 of the sum appropriated. The authority of the allottee to obligate funds appropriated by
15 this act shall lapse on September 30, 2018.

16 Section 4. Effective Date. This act shall take effect upon the approval of the
17 Governor or upon its becoming law without such approval.
