A BILL FOR AN ACT

To supplement State Law No. 11-118 at Section 2(1) to increase the budget for contractual under the Office of the Governor, Section 5(a) to decrease the budget for personnel and Section 5(b) to increase the budget for travel under the operation of the State Court and to further correct the Title section, Section 1 and Section 5 of the State Law No. 11-118, to be consistent with this supplemental amendment; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Purpose. The purpose of this act is to increase the budget for 1 contractual under the Office of the Governor at Section 2(1), and to increase the budget 2 for contractual under the State Court at Section 5(c) and to provide technical correction 3 to the Title section, Section 1 and Section 5 of State Law No. 11-118. 4 Section 2. Amendment. State Law No. 11-118, at Title section, Section 1, 5 and Section 2(1), is hereby amended to read as follows: 6 "To appropriate the sum of \$10,447,942 from the Amended Compact Fund, the 7 sum of \$1,991,557 from the State Revenue Fund, the sum of \$970,773 from the 8 United State Grant Fund; and the sum of \$55,000 from the Foreign Assistance 9 Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2018, 10 for purpose of funding the operations of all branches of the Kosrae State 11 Government, its agencies, and various programs, and for other purposes. 12 Section 1. Appropriation. Operations of the Executive. The sum of \$6,552,936, 13 or so much thereof as may be necessary, is appointed from the Amended Compact 14 Fund; the sum of \$886,316, or so much thereof as may be necessary, is 15 appropriated from the United States Grant Fund; and the sum of \$30,000 or so .16
