BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$4,000.00 is hereby appropriated from 2 the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding 3 activities of the Kosrae Community Health Intervention Program. 4 Section 2. All funds appropriated by this Act shall be allotted, managed, 5 administered and accounted for in accordance with applicable laws. The allottee of the 6 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible 7 for ensuring that these funds, or so much thereof as may be necessary, are used for the 8 purpose for which are appropriated and that no obligations are incurred in excess of the 9 sum appropriated. 10 Section 3. Effective Date.
