A BILL FOR AN ACT

To appropriate the sum of \$111,855 from the US Federal Grants of the Kosrae State Treasury to fund the Kosrae Island Resource Management Authority program in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. Appropriation. The sum of \$111,855 is hereby appropriated for the		
2	US Federal Grants of the Kosrae State Treasury for the purpose of funding programs		
3	under the Kosrae Island Resource Management Authority.		
4	Section 2. Apportionment. The fund appropriated under Section 1	of this act	
5	is apportioned as follows:		
6	1. Forest Health Protection & Invasive Plant Management	\$31,855	
7	2. Forest Stewardship	\$35,000	
8	3. Urban & Community Forest	\$45,000	
9	Section 3. Allottee & Lapse Date. All funds appropriated by this a	ct shall be	
10	allotted, managed, administered and accounted for in accordance with applicable laws.		
11	The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who		
12	shall be responsible for ensuring that these funds, or so much thereof as may be necessary		
13	are used for the purpose for which are appropriated and that no obligations are incurred		
14	in excess of the sum appropriated. The authority of the allottee to obligate funds		
15	appropriated by this act shall lapse on September 30, 2020.		
16	Section 4. Effective Date. This act shall become law upon approval by the		
17	Governor or upon its becoming law without such approval
