A BILL FOR AN ACT

To amend State Law No. 10-149 as amended by State Law No. 11-41, to further amend Title 7 at Section 7.1704 to change the Ex-Officio member of the Price Control Commission; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. Pu	rpose. The purpose of this act is to amend Title 7 at Section 7.1704
2	to change the existing	g ex-officio member of the Price Control Commission to be the
3	Director of the Depar	tment of Administration and Finance.
4	Section 2. Ar	mendments. Title 7 at Section 7.1704 of the Kosrae State Code is
5	hereby amended to re	ead as follows:
6	(1)	There is hereby established a Price Control Commission in Kosrae
7		to be composed of five members appointed by the Governor with
8		the advice and consent of the Legislature. The members appointed
9		shall be citizens residing in Kosrae State. The members appointed
10		shall not include more than one person having a controlling
11		ownership or a managerial interest in one or more businesses in
12		Kosrae. The Director for the Department of Administration and
13		Finance shall be an ex-officio member of the Commission, withou
14		the right to vote.
15	(2)	The term of office of the appointed members of the Commission
16		shall be two years. Appointments to fill vacancies shall be for the
17		remainder of the unexpired term.
18	(3)	At the first meeting and annually thereafter the Commission shall

1		elect a Chairman from among its appointed members. Meetings
2		shall be held at least once a month and may be called by the
3		Chairman, three of the appointed members, or the Governor. A
4		quorum of the Commission shall be four appointed members,
5		and the assent of three members present and voting shall be
6		required for all decisions requiring a vote. With prior approval
7		from the Governor, the Commission shall adopt regulation and
8		by-laws for its own governance.
9	(4)	Members of the Commission shall be compensated at rates
10		established by law when actually attending meetings of the
11		Commission. The Department of Administration and Finance
12		shall offer technical assistance to the Commission and provide
13		records within its possession as requested b the Commission. The
14		Attorney General shall serve as counselor for the Commission. The
15		Department of Administration and Finance shall serve as
16		Secretariat for the Commission.
17	Section 3. Ef	fective Date. This act takes effect upon the approval of the
18	Governor or upon its	becoming law without such approval.
