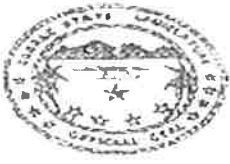

A BILL FOR AN ACT

To appropriate the sum of \$300,884.00 from the United States Grant Fund of the Kosrae State Treasury to further supplement the total amount appropriated by State Law No. 11-150 to fund the operations and activities of the Kosrae Community Health Center for budget period June 1, 2018 – May 31, 2018.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$300,884.00 is hereby appropriated from  
2           the United States Grant Fund of the Kosrae State Treasury for the purpose of  
3           supplementing the operations and activities of the Kosrae Community Health for budget  
4           period June 1, 2018 – May 31, 2019.

5           Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be  
6           allotted, managed, administered and accounted for in accordance with applicable laws.  
7           The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who  
8           shall be responsible for ensuring that these funds, or so much thereof as may be  
9           necessary, are used for the purpose for which are appropriated and that no obligations  
10          are incurred in excess of the sum appropriated. The authority of the allottee to obligate  
11          funds appropriated by this act shall lapse on May 31, 2019.

12          Section 3. Effective Date. This act shall become law upon approval by the  
13          Governor or upon its becoming law without such approval.
