The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated and that no obligations are incurred in excess of the sum appropriated.

Section 4. <u>Effective Date</u>. This act takes effect upon the approval of the Governor or upon its becoming law without such approval.
