

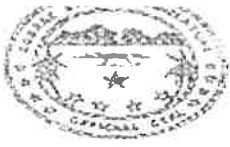

A BILL FOR AN ACT

To appropriate the sum of \$5,570 from the Revenue Fund of the Kosrae State Treasury to provide funding for the Run-Off Election to be held in the State of Kosrae on January 3rd, 2019; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$5,570 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury to provide funding for the Run-Off Election
3 to be held in the State of Kosrae on January 3rd, 2019.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered, and accounted for in accordance with applicable laws. The allottee of the
6 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
7 for ensuring that these funds, or so much thereof as may be necessary, are used for the
8 purpose for which are appropriated and that no obligations are incurred in excess of the
9 sum appropriated. The authority of the allottee to obligate funds appropriated by this act
10 shall lapse on September 30, 2019.

11 Section 3. Effective Date. This act takes effect upon the approval of the
12 Governor or upon its becoming law without such approval.
