

A BILL FOR AN ACT

To appropriate the sum of \$51,190.00 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the activities of the 2015 Strategic Prevention Framework Partnership for Success (SPF-PFS) Program.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$51,190.00 is hereby appropriated from
2 the Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding
3 activities of the 2015 Strategic Prevention Framework Partnership For Success
4 (SPFP-PFS) Program.

5 Section 2. Apportionment. The sum appropriated unde Section 1 of this Act
6 shall be apportioned as follows:

- 7 a) Personnel.....\$ 39,498.00
8 b) Travel.....\$ -0-
9 c) Consumable Goods.....\$ 11,692.00
10 d) Contractual Services.....\$ -0-
11 e) Fixed Asset.....\$ -0-

12 Section 3. Allottee. All funds appropriated by this Act shall be allotted, managed,
13 administered and accounted for in accordance with applicable laws. The allottee of the
14 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
15 for ensuring that these funds, or so much thereof as may be necessary, are used for the
16 purpose for which are appropriated and that no obligations are incurred in excess of the
17 sum appropriated.

18 Section 4. Effective Date. This Act shall become law upon approval by the


1 Governor or upon its becoming law without such approval.


