A BILL FOR AN ACT

To appropriate the sum of \$8,000.00 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the activities of the Abstinence Education Program.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1	. Appropriation. T	The sum of \$8,000.00 is hereby appropriated from the	
2	Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding			
3	activities of the Abstinence Education Program.			
4	Section 2. Apportionment. The sum appropriated under Section 1 of this Act			
5	shall be apportioned as follows:			
6	a) Po	ersonnel	\$ -0-	
7	b) T	ravel	\$ -0-	
8	c) C	onsumable Goods.	\$ -0-	
9	d) C	ontractual Services	s \$ 8,000.00	
10	e) Fi	ixed Asset	\$ -0-	
11	Section 3	. Allottee. All fun	ds appropriated by this act shall be allotted, managed	
12	administered and accounted for in accordance with applicable laws. The allottee of the			
13	funds appropriated shall be the Governor of the State of Kosrae, who shall responsible			
14	for ensuring that these funds, or so much thereof as may be necessary, are used for the			
15	purpose for which are appropriated and that no obligations are incurred in excess of the			
16	sum appropriated.			
17	Section 4. Effective Date. This act shall become law upon approval by the			
1,8	Governor or upon its becoming law without such approval.
