

A BILL FOR AN ACT

To appropriate the sum of \$1,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the July 2015 Liberation Celebration in the Utwe Municipality; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$1,000.00 is hereby appropriated from
2 the Local Revenue Fund of the Kosrae State Treasury for the providing funds
3 for the July 2015 Liberation Celebration in Utwe Municipality.

4 Section 2. Allottee. All funds appropriated by this act shall be allotted, managed,
5 administered and accounted for in accordance with applicable laws. The allottee of the
6 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
7 for ensuring that these funds, or so much thereof as may be necessary, are used for the
8 purpose for which are appropriated and that no obligations are incurred in excess of the
9 sum appropriated.

10 Section 3. Effective Date. This act shall become law upon approval by the
11 Governor or upon its becoming law without such approval.


