

A BILL FOR AN ACT

To further amend State Law No. 10-134 to de-appropriate \$15,500 from the personnel budget of Office of the Attorney General for the fiscal year ending September 30, 2015; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE:

1 Section 1. Purpose. The purpose of this act is to de-appropriate \$15,500 from the Office
2 of the Attorney General personnel budget under the Revenue Fund for the fiscal year ending
3 September 30, 2015.

4 Section 2. Amendment. State Law No. 10-134 at title, line one, Sections 1 and 2,
5 Subsection (16) are hereby amended to read as follows:

6 “To appropriate the sum of \$9,771,867 from the Amended Compact Fund; the sum
7 of \$1,808,760 from the State Revenue Fund; the sum of \$1,015,642 from the United States Grant
8 Fund; and the sum of \$183,000 from the Foreign Assistance Fund of the Kosrae State Treasury
9 for the fiscal year ending September 30, 2015, for the purpose of funding the operations of all
10 branches of the Kosrae State Government, its agencies, and various programs; and for other
11 purposes.

12 Section 1. Appropriation. Operation of the Executive. The sum of \$6,230,103, or
13 so much thereof as may be necessary, is appropriated from the Amended Compact Fund; the sum
14 of \$870,436, or so much thereof as may be necessary, is appropriated from the from the State
15 Revenue Fund; the sum of \$959,431 or so much thereof as may be necessary, is appropriated
16 from the United States Grant Fund; and the sum of \$25,000 or so much thereof as may be

1 necessary, is appropriated from the Foreign Assistance Fund for the Executive Branch for the
 2 fiscal year ending September 30, 2015.”

3 Section 2. Apportionment. Operation of the Executive. The sums appropriated by
 4 Section 1 of this act are apportioned as follows:

13 Section 3. Effective Date. This act shall become law upon approval by the Governor or
 14 upon its becoming law without such approval.






