

A BILL FOR AN ACT

To appropriate the sum of \$5,780 from the Revenue Fund of the Kosrae State Treasury to fund the 2015 Kosrae Refendum; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE:

1           Section 1. Purpose. The purpose of this act is to appropriate funding \$5,780 from the  
2 Revenue Fund of the Kosrae State Treasury to fund the 2015 Kosrae State Refendum held on the  
3 1<sup>st</sup> of July, and fund cost of related preparation activities.

4           Section 2. Appropriation. The sum of \$5,780 is hereby appropriated from the Revenue  
5 Fund of the Kosrae State Treasury to fund the 2015 Kosrae State Refendum.

6           Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,  
7 administered and accounted for in accordance with applicable laws. The allottee of the funds  
8 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring  
9 that these funds, or so much thereof as may be necessary, are used for the purpose for which are  
10 appropriated and that no obligations are incurred in excess of the sum appropriated.

11           Section 4. Effective Date. This act shall become law upon approval by the Governor or  
12 upon its becoming law without such approval.
