A BILL FOR AN ACT

To further amend State Law No. 10-134, as amended by S. L. Nos. 10-150 and 11-25, by amending the Title and Sections 3, 4, 5, and 6 thereof, to de-appropriate the sum of \$10,320 previously appropriated to fund the fiscal year ending September 30, 2015; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE:

1 Section 1. The Title of State Law No. 10-134, as amended by S. L. Nos. 10-150 and 11-
2 25, is hereby further amended to read as follows:

3 “To appropriate the sum of \$9,771,867 from the Amended Compact Fund; the sum
4 of \$1,798,440 from the State Revenue Fund; the sum of \$1,015,642 from the United States Grant
5 Fund; and the sum of \$183,000 from the Foreign Assistance Fund of the Kosrae State Treasury
6 for the fiscal year ending September 30, 2015, for the purpose of funding the operations of all
7 branches of the Kosrae State Government, its agencies, and various programs; and for other
8 purposes.”

9 Section 2. Section 3 of State Law No. 10-134, as amended by S. L. Nos. 10-150 and 11-
10 25, is hereby further amended to read as follows:

11 “Section 3. Appropriation. Operation of the Legislature. The sum of \$533,839, or
12 so much thereof as may be necessary, is appropriated from the Revenue Fund of the Kosrae State
13 Treasury for the operations of the Legislature for the fiscal year ending September 30, 2015.”

14 Section 3. Section 4 of State Law No. 10-134, as amended by S. L. Nos. 10-150 and 11-
15 25, is hereby further amended to read as follows:

16 “Section 4. Apportioned. Operation of the Legislature. The sums appropriated by
17 Section 3 of this act are apportioned as follows:

1	(a) Personnel	-0-	438,089	-0-	-0-
2	(b) Travel	-0-	10,000	-0-	-0-
3	(c) Contractual	-0-	14,000	-0-	-0-
4	(d) Others	-0-	61,750	-0-	-0-
5	(e) Fixed Assets	-0-	10,000	-0-	-0-

6 Section 4. Section 5 of State Law No. 10-134, as amended by S. L. Nos. 10-150 and 11-
 7 25, is hereby further amended to read as follows:

8 “Section 5. Appropriation. Operation of the State Court. To appropriate the sum
 9 of \$301,056 or so much thereof as may be necessary, is appropriated from the State Revenue
 10 Fund; the sum of \$25,000, or so much thereof as may be necessary, is appropriated from the
 11 from the Foreign Assistance Fund of the Kosrae State Treasury for the operations of the State
 12 Court for the fiscal year ending September 30, 2015.”

13 Section 5. Section 6 of State Law No. 10-134, as amended by S. L. Nos. 10-150 and 11-
 14 25, is hereby further amended to read as follows:

15 “Section 6. Apportioned. Operation of the State Court. The sums appropriated by
 16 Section 5 of this act are apportioned as follows:

17	(a) Personnel	-0-	217,269	-0-	-0-
18	(b) Travel	-0-	11,500	-0-	-0-
19	(c) Contractual	-0-	19,907	-0-	-0-

1	(d) Others	-0-	42,380	-0-	25,000
2	(e) Fixed Assets	-0-	10,000	-0-	-0-"


3 Section 6. Effective Date. This act shall become law upon approval by the Governor or
4 upon its becoming law without such approval.
