

A BILL FOR AN ACT

To amend at title and Section 1 of Kosrae State Law No. 11-03 to correct technical discrepancies, thereby adjusting appropriation amount from \$8,050 to \$9,650 and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1.    Purpose. The purpose of this act is to amend Section 1 of Kosrae State Law  
2           No. 11-03, to correct technical discrepancies in the funding amount appropriated by law and  
3           amount from \$8,050 to \$9,650 and for other purposes.

4           Section 2.    Amendment. State Law No. 11-03 is hereby amended at title and Section 1 to  
5           read as follows:

6           "To appropriate \$9,650 from the Foreign Assistance Fund of the Kosrae State Treasury to  
7           fund the activities of the 2015 Inauguration Ceremony.

8           "Section 1. Appropriation. The sum of \$9,650.00 is hereby appropriated from the Foreign  
9           Assistance Fund of the Kosrae State Treasury for the purpose of funding the 2015  
10          Inauguration Ceremony."

11          Section 3. Effective Date. This act shall become law upon approval by the Governor or  
12          upon its becoming law without such approval.


